Booking/cancellation guidelines



When cancelling a trek/trip with Roamix International, please take note of the following cancellation guidelines:., please take note of the following cancellation guidelines:

Initial Booking Amount of 30% is to be collected from the clients. One third of the initial booking amount is non-refundable under any circumstances.

Cancellation by the Participant:

If a participant cancels the trek/trip more than 30 days before the scheduled departure date, they will receive a refund of 70% of the total trek cost (excluding the initial booking amount).
If a participant cancels the trek/trip between 15 & 30 days before the scheduled departure date, they will receive a refund of 50% of the total trek cost (excluding the initial booking amount).
If a participant cancels the trek/trip less than 15 days before the scheduled departure date or fails to show up for the trek, no refund will be provided.

Cancellation by Roamix International:

In the unlikely event that Roamix International cancels a trek/trip due to unforeseen circumstances or insufficient bookings, participants will receive a full refund of the total trek cost, including the initial booking amount.

If any inconveniences occur such as natural calamity, accidents, bad weather condition, change of plan by the clients take place, in that case the hotel/Homestay/tent site/property or such accommodation, booked for that PARTICULAR day/date/time/duration, 50% cancellation amount against the total booking amount will be automatically charged upon the participant. If failure to clear such payment shows up, services provided by the company will be suspended/withheld until the issue resolved.
